



Contract

Exhibitor will abide by and be subject to the following agreement as a condition for acceptance as an exhibitor at The Boston Christmas Festival.

1. All crafts to be displayed at my booth at The Boston Christmas Festival are my own creation, or that of my family.
2. I will not sublet booth space nor act as a dealer for other craftsmen or manufacturers.
3. I understand that the promoter reserves the right to remove, without refund or recourse, any exhibitor who misrepresents himself or his product.
4. I agree to comply with all local and state regulations. I will have no open flames unless I receive written permission in advance of the show.
5. I will obtain all tax, vendor, or other permits as required by local or state authorities at my own expense.
6. I understand that sale signs are prohibited and that I must store excess stock out of sight. I agree to abide by move-in and move-out regulations as stipulated by the promoter. I further agree to remain set up for the duration of the show.
7. Exhibitor booth must have a backdrop. Christmas/Holiday decorations are encouraged. Nothing is to be placed in the aisles. No kits, imports, or manufactured items.
8. My enclosed check represents a commitment to show. Once accepted, I understand that any exhibitor who fails to appear one hour before show opening forfeits his right to exhibit without refund or recourse.
9. I will not hold Artisan Promotions, Inc., its agents, employees or officers liable for failure to perform or fulfill its contractual obligations provided such failure is caused, occasioned or impeded by closures of site location due to any causes beyond its control. Nor will I hold the promoter or owners or managers of the exhibit hall responsible for loss or damage of exhibitors' wares, exhibits, or personal property or for loss or injury caused by products sold or exhibited by exhibitors directly or through warranty express or implied. Insurance for such loss, damages or injury will be my sole responsibility.
10. If my check is returned due to insufficient funds, I agree to replace it with a money order or teller's check, or to forfeit my place at The Christmas Festival. A \$35 fee will be assessed for returned checks.
11. It is agreed that Artisan Promotions, Inc. reserves the right to amend and/or add to the applicable rules pertaining to and governing this show at any time prior to the commencement of said show. Additions or amendments will be circulated to exhibitors in writing. The interpretation of all rules by the promoters shall be final.



12. In addition, I expressly release the Promoter, Artisan Promotions, Inc. and the owners of the exhibit hall of and from any and all liability for any damage, injury, or loss to any person or goods which may arise from the rental and occupation of said space or the participation in this show by the Exhibitor, and agree to hold and save the producer and owners of the Exhibit Hall harmless of any loss, injury or damage by reason thereof. I further agree that no employment is created by this Contract.

If my application is accepted, I give permission to use my images and any other materials submitted for publicity purposes.

Application to this show constitutes Exhibitor agreement of this release.
